## **The Aeronautical Society of India**

### **Brief History**

The Aeronautical Society of India was founded on 17<sup>th</sup> November 1948. The Society's Headquarter is located at 13 - B, Indraprastha Estate, New Delhi - 110 002 which was inaugurated on 4<sup>th</sup> April 1963 by Hon'ble PM Pt. Jawaharlal Nehru, the first Patron-in-Chief of the Society.

In these illustrious traditions, Dr. S. Radhakrishnan, Smt. Indira Gandhi, Shri Rajiv Gandhi, Shri P. V. Narasimha Rao, Shri H. D. Deve Gowda, Shri I. K. Gujral and Dr. Manmohan Singh were the successive Patrons-in-Chief of the Society. Late Dr. APJ Abdul Kalam guided the Society as its President during year 1992-94.

### **Objectives**

The objectives of the Society are to promote the advancement and dissemination of knowledge of Aeronautical and Aerospace Sciences / Technologies. To aim for high standards of education, research, safety, quality and training in all fields of Aeronautical and Aerospace profession. To undertake policy advocacy and to bring synergy between the Aerospace professionals, institutions, industries and government. To strive for the elevation of Aeronautical and Aerospace profession.

***In order to achieve these objectives, the Society shall engage in the following activities:***

- a) Promotion of the professionalism of its members by setting up and maintaining a high standard of competency and by strict enforcement of rules of personal conduct as condition of Membership.
- b) Organisation of lectures and discussions and the publication of papers dealing with various branches of Aeronautics.
- c) Establishment of a library of Aeronautical Publications.
- d) The purchase, lease or acquisition by any other lawful means and the disposal of any premises or any other property for the purposes of the Society, subject to the provisions of the Societies Registration Act, 1860.
- e) Printing, Publication, Sale, Loan or Distribution of such documents as may be found desirable.
- f) Conduct of Examinations and award of Certificates, Prizes, Scholarships and Stipends.
- g) Printing, Publishing, Sale, Loan or distribution of such documents as may be found desirable and publishing a quarterly International Journal and monthly E-news.
- h) Fraternalization amongst professionals.
- i) Enroll individuals, Institutions & Industries as Members.
- j) Encourage Indian authors to write Books, Monographs Approach Papers on Aeronautical/ Aerospace subjects.

- k) Conduct, centrally and through its Chapters, regular Annual Seminars and Conferences in the areas of technical, academic and professional interest, in addition to special seminars of topical interest.
- l) Encourage young professionals to participate in International and National Conferences.
- m) Confer Awards of Excellence. Conduct Annual Essay Competitions for Students/Scientists/Engineers.
- n) Provide a platform for Industry – R & D - Academia interaction.
- o) Participates with the Government in the formulation of policies, procedures and guidelines.

### **Organization**

Over the years, the Society has grown into a major professional body in the field of aeronautics, aviation and aerospace. The Society has 18 Branches at all the important centers of aviation in the country viz., Ahmedabad, Agra, Bangalore, Chandigarh, Chennai, Delhi, Goa, Hyderabad, Kanpur, Kanyakumari, Kochi, Kolkata, Mumbai, Nashik, Nagpur, Pune, Sunabeda, Thiruvananthapuram and two Divisions (CFD Division & Design Division) at Bangalore.

Its membership of more than 15226 is drawn from all major aeronautical establishments such as Hindustan Aeronautics Limited, DGCA, Defence Research and Development Establishments, Academic Institutions, Aeronautical Development Agency, Indian Air Force, Indian Space Research Organization, Vikram Sarabhai Space Centre, National Airport Authority of India, Air India, Jet Airways, Pawan Hans and aero industry in private sector. The Society has 69 Corporate Members from both national and international sectors.

### **Management**

The Society is managed by a Council consisting of a President, President – Elect, seven Vice Presidents, the Honorary Secretary General, Honorary Treasurer and fifteen members, twelve of whom are elected and the other three nominated to represent special interests.
