

## **APPENDIX "A"**

**Rule 77:** At least two months before the Annual General Meeting in each year the Council shall send to each member notice of duly qualified persons whom it nominates as candidates for election at the said Annual General Meeting for the office of the Vice Presidents, Honorary Secretary General, Honorary Treasurer, other members of the Council and President –Elect (if applicable in terms of Rule-74), after obtaining written consent from the nominee. Duly qualified persons shall include all members of the Society who have paid their subscription or deemed to have paid their subscription.

**Rule 78:** After issue of the notice as mentioned in the preceding Rule, any 10 members who have paid their subscriptions for the current financial year, may nominate within fifteen days of issue of notice and/or its posting on the official web-site of the Society, but not later, any other duly qualified person, (who has paid his/her subscription or deemed to have paid his/her subscription for the current financial year), as a candidate for election to any one or more the said offices by depositing at the Society's Head Office (a) such nomination in writing together with (b) the written consent of the nominee to accept office if elected. Any such nominations received without the above mentioned documents and/or later than 15 days of the issue of notice and/or its posting on the official web-site of the Society, shall be invalid and hence rejected. No member may nominate more than one candidate for the same office in any year.
